The European Commission issued specific guidelines regarding the freedom of movement of citizens in Europe for health reasons.

Freedom of movement concerns also doctors but following the validation of the title in the Countries in which they choose as place to exercise their professional activity. But we know that knowledge and skills acquired during the specialist training course in the different countries of the European Union vary from the viewpoint of quality and quantity even in respect of the right and the recognition of the title in each European Country.

Even if the European Union does not have any direct responsibility in the management of health, it is interested in ensuring consistency of services and health care services for 480 million citizens of the 27 Member States. However, this interest of the European Union clashes with the lack of shared training standards of the specialist, defined as the doctor who completed satisfactorily a specialist training programme in a recognized specialty. Currently, there is only the Directive 2005/36EC defining the minimum duration of specialist training but the contents of such training were not defined at legislative level, and also criteria for the assessment and maintenance of post-specialty standards are not consistent.

As institutional representatives of the medical profession and in order to ensure protection of citizens' health, the Italian Federation of the Orders of Doctors and Dentists (FNOMCeO), the Provincial Order of Doctors and Dentists and the European Medical Organizations deem it proper to commit themselves in order to guarantee, in cooperation with Universities, the harmonization of contents, time and standards of courses for specialist medical training throughout Europe.

This is intended to be an occasion to take into consideration the different aspects, to represent criticalities, to present the experiences already existing and to share programmes and commitment for the future, so as to identify a path that enables to guarantee uniform attention to the health needs of European citizens as well as a common high professional quality.
